

RECOMMENDED TOOLS: Hack saw, pipe joint sealant, screwdriver, level, 12" adjustable wrench, 10" pipe wrench, 3/32" and 5/32" hex key wrench, 9/16", 1/2", 7/16" socket wrench or open end wrench.

LOCATION OF UNIT: The Model 3377/3377G Drinking Fountain is a wheelchair accessible drinking water facility. The height dimensions shown, meet current ADA requirements. SUPPLY LINE: The minimum recommended line size is 1/2"IPS with 30-90 psi (2-6 ATM) flowing pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.


PLUMBING CONNECTIONS: Inlet is 1/4" IPS male fitting. Waste outlet is 1-1/4" Slip Joint.
